**MINIMUM REQUIREMENTS:**

- Applicant must present a valid California Driver's License to qualify.
- A **DD214** must be presented at the time of Application, at the San Mateo J.A.T.C. (625 Industrial Road, San Carlos, CA 94070).
- It is the responsibility of the applicant to provide copies of all required documents. No copies will be made by the JATC.
- Applicants who meet the minimum requirements will be scheduled for an Oral Interview.
- Pre-employment Drug Testing will be required.

**BURDEN OF PROOF IS THE APPLICANT'S RESPONSIBILITY**

**HOURLY WAGE:**

- Starting wage as provided by the Collective Bargaining Agreement.

**AGE:**

- Applicant must be eighteen years of age or older.

## DATE OF INTERVIEW:

- An honorably discharged United States military veteran will qualify for an oral interview by the SMJATC. Applicants who have served overseas and/or lived on base for a minimum of two (2) years prior to application will have any existing residency restriction waived. This is a method of direct interview. Qualified Applicants will be notified by mail of the exact date, time and place to report for the Oral Interview.

## CHARACTERISTICS OF THE TRADE:

- The Apprentice works directly under the supervision of a Journeyman Electrician. The trade requires considerable physical effort on the part of the Apprentice to do climbing, crawling, crouching and working in cramped quarters. Wiring is frequently color-coded and therefore, the worker cannot be colorblind. Mechanical ability and finger dexterity are essential. Electrician's work may be performed either indoors or outdoors, in existing or new buildings under construction, including street and highway lighting, traffic signals and other outdoor above and below grade installation, regardless of weather conditions.
